

Frederick County Virtual School (FCVS)

2021.2022 VOS Registration Packet

The VOS (Virtual Outside of School) Program is designed for independent and self-motivated learners. VOS offers honors level courses and electives.

While a complete and detailed academic agreement will be completed at the course orientation, students and parents/guardians should know and agree to the general principles of the virtual school program before pre-registering.

1. TIME and COMMITMENT

- Virtual courses are rigorous and academically challenging!
- A substantial commitment is required by the student. Virtual learning is NOT the best option for all learners.
- Students should make and keep a schedule that commits 5-8 quality hours each week for the course.
- Virtual courses have different start and end dates. See the Master Schedule in this document for dates/times.
- Students should expect that no course extensions will be granted.

2. ATTENDANCE

- Review the FCVS Master Schedule @ <https://education.fcps.org/fcvs/> or in this packet.
- Confirm that you can participate in the scheduled synchronous Google Meet session dates and times for VOS.
- Absences related extracurricular activities, vacation, or work schedules are not excused.
- MANDATORY eOrientation: A link will be sent to students and Parent/Guardian emails. Completion of eOrientation is required before beginning the course. Once completed, course access credentials will be provided via email.
- Failure to meet attendance requirements will result in removal from the course without refund.

3. PARTICIPATION EXPECTATIONS

- Respond promptly to communications from the instructor or the Virtual School Office.
- Weekly engagement and participation in Google Meet.
- Submit assignments as scheduled/described in the course syllabus.

4. COMMUNICATION (email is the primary means of communication)

- Students must use "my.fcps.org" email account. Parents are required to provide FCVS with a current, working email.

5. GRADES and TRANSCRIPT

- Weekly progress reports will be emailed to students, parents, and counselors.
- At a minimum, mid-term and final exams must be scheduled in advance with the instructor who will open and close exams at specified times.
- FCVS does not issue term grades. Students will receive one final letter grade upon courses completion.
- Academic integrity expectations and consequences can be found in the orientation and the course syllabus.
 - Please refer to FCPS Regulation 400-08 regarding plagiarism and cheating.

6. FORMAL EDUCATION PLANS

- Many students with IEPs and/or 504 plans have successfully earned credit in virtual courses. However, this instructional model is not the best option for all learners, or able to support all accommodation needs. Students with formal education plans are enrolled on a case-by-case basis through collaboration between FCVS and the home school staff.

7. DEADLINES: PRE-REGISTRATION and FEES

- Students register with their school counselor; courses fill quickly and enrollment is not guaranteed.
- Non-refundable fee is based on a sliding scale associated with documented school meal status.
- The fee is to be paid at a secure online site after notification of enrollment via email.
- Failure to make the payment deadline** will result in automatic removal from the course.

FORMAL LEARNING PLANS AND VIRTUAL COURSES FOR CREDIT

AGREEMENT PREMISE

Formal learning plans are designed for implementation in a traditional classroom in a comprehensive school setting. FCVS programs offer different levels of support in various learning environments. Students with formal education plans are enrolled on a case-by-case basis with collaboration between Virtual School Administration, Special Education case managers, and school counselors.

We have read and understand the following points regarding implementation of accommodations in the online learning environment:

1. Many students with IEPs and/or 504 plans have successfully earned credit in online courses. However, this instructional model is not the best option for all learners, or able to support all accommodation needs.
2. Many accommodations are integrated into virtual courses. Some accommodations may not be provided.
3. Accommodations may be provided differently than in the traditional school setting.
4. Successful Online Learner Attributes include:

➤ Self-motivated to direct their own learning	➤ Consistent attendance patterns
➤ Level of maturity to collaborate with the online instructor and/or mentor	➤ Submit work in a timely manner based on the syllabus timeline
➤ Willing to ask for help or clarification when needed	➤ Must be willing to work outside of required program face to face time with instructors
