TERMS AND CONDITIONS OF PARKING PRIVILEGES

*All of the following statements below must be read and **initialed** by both the parent and the student.*

- ___ 1) I understand that students are not encouraged to drive to school. The privilege is offered by officials for special situations.
- ___ 2) I have been provided and read all rules and regulations governing the THS student-driving program. (Parking Application/Contract and Attachment #1)
- ___ 3) I understand that in consideration of the permission to park at THS, the school administration retains the authority to search my vehicle at any time when it is on the campus.
- ___ 4) I agree to abide by all rules and regulations of the THS student-driving program. I understand that if my car is parked illegally, I may be fined and/or my car towed at my expense. Illegal parking includes, but is not limited to, parking without a visible permit, parking in fire lanes, parking in grass areas and/or parking in lots designated for staff only. **I understand the progression for illegal parking will be as follows:**

FIRST OFFENSE		Warning
SECOND OFFENSE	\$10 fine	Student conference and parent contact (letter)
THIRD OFFENSE	\$15 fine	VEHICLE TOWED at the expense of the student/parent

- ___ 5) I understand that my vehicle must be secured (locked) while on campus and that the school/Board of Education will not assume responsibility for losses from, or damages to, my vehicle while it is on THS property.
- ___ 6) I understand that I MAY NOT loan or transfer my permit to another student. Violation will result in revocation of my permit.
- ___ 7) I understand that I may not park in spaces identified for visitors, reserved or handicap (without a valid handicap sticker).
- ___ 8) I understand that my vehicle must be removed from rows 1-4 no later than 4:15 each day. This is to allow for practice space for the performing arts.

There is a \$10.00 fee for lost permits to be reissued.
